Scott McGeary is a Project Manager, Government Relations and Public Policy, for Washington Gas, a public utility and energy services retailer serving Virginia, Maryland, and the District of Columbia. He represents the interests of Washington Gas before state and local government, business organizations, and community groups. In addition to representing the company during annual sessions of the Virginia General Assembly, McGeary administers Corporate Public Policy programs in Virginia.
